Members,

We have received direction regarding the submission of MOAs regarding participation in the 287g Taskforce Models. The fillable TFM is attached for your convenience; please note there is a section that ICE must complete as well. Agencies completing these MOAs should forward their signed document to ERO287g@ice.dhs.gov.

The State of Florida has two ICE Office of the Principal Legal Advisor (OPLA) field locations who are co-located in the same buildings as their respective local EOIR court location. The LEAs can use the EOIR location tool linked below to find the OPLA address that corresponds to their location.

The only difference between the listed court address and the OPLA address is the floor. OPLA Orlando is on the 5th floor (Suite 5000), and OPLA Miami is on the 2nd floor (Suite 200).

Once you submit your MOA's they should be executed within 2 business days, and you should see them appear on the portal. Updates to this portal are made routinely and you can click on the links to participating agencies or pending agencies to see your status.

287(g) Participating Agencies

As of March 4, 2025, at 3:00 p.m., ICE has signed 287(g) JEM agreements with 72 law enforcement agencies in 20 states, 287(g) WSO agreements with 123 law enforcement agencies in 16 states, and 287(g) TFM agreements with 107 agencies in 12 states.

Regarding 287g training for LEA personnel, ICE is in the process of updating a virtual option for the immigration enforcement MOU which is anticipated to be available within the next week, or early March 2025. Tentatively, the training is 40 hours to be completed within a 60-day timeframe (enforcement MOU). Information regarding training opportunities should be available on the above weblink for ICE. As we learn of these opportunities, we will update our membership.

The FPCA cannot provide additional guidance for agencies on the number of personnel that you should provide or full/part time status of those members that may participate in TF operations.
