The FPCA has provided ongoing updates regarding immigration enforcement and reporting requirements as part of communications from FDLE and the State Board of Immigration Enforcement. There have been questions raised about the summary reporting and incident reporting as articulated in the emergency draft rules associated with immigration law. Earlier this week, the Cabinet and the State Board of Immigration Enforcement approved the rule package as presented by FDLE that includes reporting requirements by all agencies, local, county detention, state attorneys.
